

# Summer Discovery Refer-A-Friend Terms and Conditions

As a member of Summer Discovery's Refer-a-Friend Program (a "Promoter"), you are subject to Summer Discovery's [Terms of Use](#), Summer Discovery's [Enrollment Terms](#) and Summer Discovery's [Privacy Policy](#), as well as the following additional Terms & Conditions for Summer Discovery's Refer-a-Friend Program:

## Accrual Period

This is the period in which Promoters can accrue Referral Fees from Qualified Recipients they provide Summer Discovery. This period runs the consecutive months starting on September 1 of the current year and ends on August 31 of the following year.

## Promoter

A person that, in good faith promotes Summer Discovery Programs. This person has been given their own Summer Discovery Referral Code to provide to individuals who may have interest in enrolling in a Summer Discovery Program.

## Recipient

A person that has registered for the Summer Discovery Refer-a-Friend Program via the Refer a Friend link they received from a Promoter.

## Qualified Recipient

A Qualified Recipient is defined as a student that is (a) directly referred to Summer Discovery by you (b) has never applied or enrolled in any Summer Discovery Program previous to your referring them this Accrual Period (c) has never been previously referred to Summer Discovery by you or any other Promoter (d) Is not a current Accrual Period Qualified Recipient from an existing Summer Discovery Partner, Referral Service or International Agency (e) has arrived to Summer Discovery by clicking on the unique Refer-a-Friend program link you provided them and entering their contact information.

## Ineligible Programs.

The Summer Discovery programs that are ineligible for the Summer Discovery Refer-a-Friend program and do not qualify for remuneration are: Johns Hopkins University, The University of Pennsylvania (excluding Penn Law Programs), The Wharton School of the University of Pennsylvania, Georgetown Hoya Summer Sessions and all programs run by The Summer Institute for the Gifted. Summer Discovery reserves the right to amend this list of ineligible programs at any time and at its sole discretion.

## Eligibility

Eligibility in Summer Discovery's Refer-a-Friend Program is limited to individuals only. Summer Discovery's Refer-a-Friend Program cannot be used by businesses for affiliate lead generation and/or posted on discount sites.

## Remuneration

Promoters will receive a one-time Referral Fee, in the form of a \$50.00 USD Gift Card, for each Qualified Recipient that enrolls in, pays in full for, and completes a Summer Discovery Program in the same Accrual Period they were referred.

Qualified Recipients will receive a one time Referral Fee, in the form of a \$50.00 USD Gift Card, for enrolling in, paying in full, and completing, a Summer Discovery Program in the same Accrual period they were referred.

Payments of referral fees for both Promoter and Qualified Recipients will be issued no earlier than 30 days of the end of the Accrual Period.

Federal, State, and local taxes are the responsibility of the Promoter or Qualified Recipient.

## Limitations

As a Promoter, you are limited to one Qualified Recipient for each Referral; in other words, additional/repeat purchases made by a Recipient are not counted as additional Qualified Recipients.

Referral links shared to or obtained through other sources (for example, posting to third-party websites) will not be honored.

The Recipient and the Promoter cannot be the same person (for example, by using an alias or a different email address).

The Promoter cannot be the sibling, parent, step-parent or legal guardian of the Recipient.

The Recipient must register with Summer Discovery via the Refer a Friend link provided by Promoter to be eligible.

At any point, and at its sole discretion, should Summer Discovery determine, based on any historical information or information provided by you, or the person that referred you, that the Recipient is not a Qualified Recipient, as defined above, no Referral Fee will be paid to the Qualified Recipient or the Promoter.

## Compliance with Law

As a Promoter, you agree to comply with all up-to-date laws, including, but not limited to [G.D.P.R](#) & the [CAN SPAM Act of 2003](#). Any distribution of your unique referral link that could constitute unsolicited commercial email or "spam" under any applicable law or regulation is expressly prohibited and will be grounds for immediate termination of your account and exclusion from Summer Discovery's Refer-a-Friend program.

## Communication Guidelines

We are providing you a referral code and link to share privately with friends, family, colleagues, co-workers etc. You are not authorized to make any marketing claims, including claims of discounts, or offer any incentives for customers to enroll other than the \$50.00 USD referral fee. Any communications that you do make in connection with referrals must be honest and accurate. As part of your participation in the Program, you must disclose in any referral communication the fact that you are a current applicant and/or enrollee of Summer Discovery, and that you may receive a \$50.00 USD Referral fee any successful referral.

## Right to Close Accounts

Summer Discovery reserves the right to close and/or suspend the account(s) of any Promoter and/or Recipient and to request proper payment if the Promoter and/or Recipient attempts to use the Summer Discovery Refer-a-Friend program in a questionable manner or breaches any of these Terms & Conditions or is in violation of any law, statute or governmental regulation.

Summer Discovery is under no obligation to pay referral fees to Promoter or Qualified Recipient in the event of a breach of these Terms & Conditions.

## Relationship

You acknowledge and agree that nothing in these terms authorizes you to act as an agent on our behalf, nor on behalf of our parents & students, and that nothing herein shall be construed to constitute a or imply a joint venture, employer-employee relationship, partnership or association between you and Summer Discovery or our customers.

## Termination

Summer Discovery reserves the right to cancel the Refer-a-Friend Program or to alter, change or modify these Terms & Conditions at any time in its sole discretion. It is your responsibility to check the [Terms & Conditions](#) page on the Summer Discovery website regularly to determine whether these Terms & Conditions have been modified. If you do not agree to any modification of these Terms & Conditions, you must immediately cease participation in the Program.
